Implementation of CCTV Solution for Africa Re

1.0 INTRODUCTION

The African Reinsurance Corporation (Africa Re) is an International Financial Institution with Headquarters in Lagos (Nigeria). Africa Re has six Regional Offices in Casablanca (Morocco), Nairobi (Kenya), Abidjan (Côte d'Ivoire), Port Louis (Mauritius), Lagos (Nigeria) and Cairo (Egypt); two subsidiaries in Johannesburg (South Africa) and Cairo (Egypt) as well as a Local Office in Addis Ababa (Ethiopia). The Corporation is owned by 41 member States of the African Union (AU), the African Development Bank (AfDB), the International Finance Corporation (IFC), IRB-Brasil Re, AXA, FairFax Holdings International and 109 African insurance and reinsurance companies.

The purpose of this RFP is to solicit proposals from vendors qualified to implement and deploy a CCTV solution for the Africa Re office in Lagos Nigeria.

2.0 BACKGROUND

AFRICA RE Lagos office currently has existing analogue CCTV Cameras and is desirous of replacing them with IP Cameras and related solutions. The Corporation has identified the BOSCH CCTV solution as appropriate to meet her needs.

3.0 OBJECTIVES & SCOPE OF WORK

For this project, African Reinsurance Corporation (Africa Re) seeks for a Vendor or Service Provider that will implement the BOSCH CCTV solution to achieve the following among others:

1. Provide IP based camera and solutions
2. Remotely accessible through secured web-based interface to view real-time footage using devices like computers, smart phones, tablets etc.
3. Intelligence operations to include remote control, video analytics, motion detection etc.
4. Scalable for seamless growth and addition of more cameras
5. Power over Ethernet (POE) compliant
6. Night vision capability as well as ability to record in areas with uneven light and make actions clearer and easier to see.
7. Support for PTZ to enable panning, tilting and zooming to capture and follow all actions.
8. Tamper detection for cameras. System should be able to generate email alerts whenever restricted perimeter is breached.
9. System should have capability for remote focus control and adjustment through the use of software for selected cameras
10. Video Compression for efficient storage of video files

4.0 PRESENTATION OF TENDER

In order to facilitate the analysis of responses to this RFP, firms are required to prepare their proposals in accordance with the instructions outlined in this section.

4.1 Executive summary

This part of the response to the RFP should be limited to a brief narrative highlighting the firm's proposal. The summary should contain as little technical details as possible, and should be oriented towards non-technical personnel. The Executive Summary should not include cost quotations.

4.2 Experience of the Contractor

The contractor must provide the following information about their company so that Africa Re can evaluate their stability and ability to support the commitments set forth in response to the RFP. Africa Re may require a firm to provide additional documentation to support and/or clarify requested information.

4.3 Approach and methodology

In this chapter, you should explain your understanding of the objectives of the assignment, approach to the services, methodology for carrying out the project and expected output.

5.0 Work plan

In this chapter, you should propose the main activities of the deployment, their content and duration, phasing and interrelations, milestones and delivery dates. A list of the final documents, including reports, drawings, and tables to be delivered as final output, should be included here. The work plan should be consistent with the Work and Deliverables Schedule.

6.0 Organization and Staffing

In this chapter, you should propose the structure and composition of your team. You should list the main disciplines of the assignment, the key expert responsible, and proposed technical and support staff.

7.0 Cost quotations

The firm's cost quotations must be itemized according to the BOM. Another cost summary should be presented for the phases of the project and tied to the project's milestones (deliverables).

8.0 Resumes

The firm must make every effort to select staff for the project based on the corporation's needs. Applicable resumes should be included in this section.

- ❖ Project Cost
